2018 was a year of renewal for the ICDA, in which we saw positive changes throughout the organisation. We accelerated implementation of the strategy defined in 2017, and delivered on key focus areas.

#### **GENERAL ASSEMBLY**

ICDA ordinary members in good standing voted for 7 resolutions during a general assembly held in Paris on April 25, 2018.

The ICDA appointed an expert lawyer to conduct a full review of its existing antitrust policy. The updated proposal was distributed to all the ICDA ordinary members and approved by a majority of votes during the general assembly.

Further articles in the ICDA by-laws have been amended. The ICDA membership has grown over the years, and the service offer has developed, necessitating the creation of by-laws in accordance with the ICDA's current activities.

All the approved resolutions can be consulted by members upon request to the ICDA secretariat.

The ICDA reiterated its commitment to best practice governance and the manner in which its activities are conducted. Anyone dealing with the ICDA must comply with the antitrust rules and code of conduct.

Sound health, safety and environmental performance is seen as a critical success factor for ICDA members. Society increasingly demands information on product safety, covering all stages of their life cycle. The sustainability of our markets will be increasingly related to observance

of the highest health, safety & environment standards.

- European HSE committee meeting in Aachen, Germany, hosted by Elektrowerk Weisweiler – Afarak Group
- China HSE committee meeting in Fengzhen, hosted by Xin Gang Lian
- Southern Africa HSE committee meeting in Rustenburg, South Africa, hosted by Tharisa Minerals
- Launch of a socio-economic assessment in partnership with Roskill, studying the economic benefits of chromium in some of the main producing regions
- Decision to recruit a senior toxicologist and take back the leadership in REACH and regulatory activities
- Review our risk assessments and update our scientific reference database
- Launch the 4<sup>th</sup> edition of our Life Cycle Assessment for the production of high carbon ferrochrome



#### **MARKET RESEARCH**

Greg Taurog Market Research Chairperson (Executive: New Business, Tharisa Minerals)

Having consolidated our position as a source of accurate data, we are looking at the specific needs of our membership in terms of in-depth study. A China ferrochromium market study is in preparation for the first half of 2019. We are also looking at diversifying our offer in the

near future in addition to the usual weekly market update, quarterly and annual reports.

- Improve readability and diversity of information in the weekly market updates
- Launch of a detailed market study of the Chinese ferrochromium market
- Presentation of data at various industry conferences



### MARKET DEVELOPMENT

Yuji Kubo Market Development Chairperson (Head of Division General Manager, NSSC)

Chromium is never used alone, and is an essential ingredient with intrinsic properties providing remarkable resistance to corrosion, extreme temperatures, wear and abrasion, to mention but a few.

Our working group is focusing on chromium's main application, which is in stainless steel but not exclusively. We are reviewing our approach in order to study non-stainless alloys and innovative developments which require chromium for sustainable applications.

- Assessing the recycling rate of all grades of stainless steels through a Yale University partnership results published in 2019 showed that overall 86% of stainless steel is being recycled
- A KTH Royal Institute of Technology study in Sweden demonstrated that all grades of stainless steel are safe to use for food preparation as per the Council of Europe guidelines for metals and alloys in food contact materials
- Another study in partnership with AgroParisTech, Manchester University and Anios laboratories concluded that stainless steel in a hospital environment is a safe choice
- We worked in partnership with Eurofer to prevent misleading classification of stainless steels using scientific facts
- In partnership with Team Stainless, we are promoting the use of stainless steel for water pipes as successfully demonstrated in Tokyo, which saved water, a precious resource



#### CHINA

Jonathan Qiu China Chairperson (Assistant General Manager, Mintal)

2018 was the kick-off year for the China committee. The group had a busy year, with 3 major events organized for the ICDA in China during the year. China is a driving force for the chromium industry, and the ICDA can only be truly global by developing a strong presence in the country.

- First ICDA Chinese New Year dinner in Beijing, a success with more than 120 attendees
- Best-practice-sharing workshop in Fengzhen, Inner Mongolia Safe Use of Ferrochromium Slag in Road Construction
- Active support for the organization of Chromium 2018 in Baotou
- Regular meeting with the Chinese industry to provide guidance to the ICDA
